Sonn and Erez Announces Investigation of Behringer Harvard Holdings and Behringer Harvard Strategic Opportunity Fund

Behringer Harvard informed brokers last week of the fund's problems and is preparing to inform investors by Friday. The Strategic Opportunity Fund was a private placement investment sold to investors by numerous brokerage firms including IMS Securities.

"Investors who invested in these funds may not have been told by their broker of the greater risks of these illiquid investments and that the investments were unsuitable," said Jeff Erez, Esq. Investors in such a circumstance may... Behringer Harvard raised \$65 million in its Strategic Opportunity Fund 1 and \$62 million in its Strategic Opportunity Fund II.

"Investors should act to protect their legal rights as certain claims may be barred by the passage of time," said Jeff Sonn, Esq.
